- Evacon Group" shall mean Exacon Group Pty Ltd its successors and assigns or any person acting on behalf of and with the authority of Exacon Group Pty Ltd "Customer" shall mean the Customer (or any person acting on behalf of and with the authority of the Customer of any person acting on behalf of and with the authority of the Customer) as described on any quotation, work authorisation or other form as provided by Exacon to the

 "Guarantor" means that person (or persons), or entity, who agrees to be liable for the debts of the
 Customer on a principal debtor basis.
 "Goods' shall mean Goods supplied by Exacon to the Customer (and where the context so permits shall
 include any supply of Services as hereinafter defined) and are as described on the invoices, quotation,
 work authorisation or any other forms as provided by Exacon to the Customer.
 "Services" shall mean all Services supplied by Exacon to the Customer and includes any advice or
 recommendations (and where the context so permits shall include any supply of Goods as defined above).
 "Price" shall mean the price payable for the Goods as agreed between Exacon and the Customer in

 The Customer shall give Exacon not less than fourteen (14) days prior written notice of any proposed change of ownership of the Customer or any change in the Customer's name and/or any other change in the Customer's details (including but not limited to, changes in the Customer's address, facsimile number, or business practice). The Customer shall be liable for any loss incurred by Exacon as a result of the Customer's failure to comply with this clause.

 Goods are supplied by Exacon only on the terms and conditions of trade herein to the exclusion of anything to the contrary in the terms of the Customer's order notwithstanding that any such order is placed on terms that purport to override these terms and conditions of trade.

Price And Payment

 At Exacon's oble discretion the Price shall be either:
 (a) as indicated on invoices provided by Exacon to the Customer in respect of Goods supplied; or
 (b) Exacon' quoted Price (subject to clause 4.2) which shall be binding upon Exacon provided that the
 Customer shall accept Exacon' quotation in writing within thirty (30) days.

 Exacon reserves the right to change the Price in the event of a variation to Exacon' quotation.

Delivery Of Goods

- 5. 5.1 At Exacon' sole discretion delivery of the Goods shall take place when:

 - (a) the Customer takes possession of the Goods at Exacori address; or (b) the Customer's nominated carrier takes possession of the Goods in which event the carrier shall be deemed to be the Customer's agent.

 At Exacori sole discretion the costs of delivery are:

The Customer's shall make all arrangements necessary to take delivery of the Goods whenever they are 5.3 The Customer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery. In the event that the Customer is unable to take delivery of the Goods as arranged then Exacon shall be entitled to charge a reasonable fee for redelivery. Delivery of the Goods to a third party nominated by the Customer is deemed to be delivery to the Customer for the purposes of this agreement. Exacon may deliver the Goods by separate instalments. Each separate instalment shall be invoiced and paid in accordance with the provisions in these terms and conditions. The failure of Exacon to deliver shall not entitle either party to treat this contract as repudiated. Exacon shall not be liable for any loss or damage whatever due to failure by Exacon to deliver the Goods (or any of them) promptly or at all, where due to circumstances beyond the control of Exacon.

- If Exacon retains ownership of the Goods nonetheless, all risk for the Goods passes to the Customer on
- If any of the Goods are damaged or destroyed following delivery but prior to ownership passing to the 6.2 Customer, Exacon is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by Exacon is sufficient evidence of Exacon rights to receive the insurance proceeds without the need for any person dealing with Exacon to make further enquiries.

- Exacon and Customer agree that ownership of the Goods shall not pass until:

 (a) the Customer has paid Exacon all amounts owing for the particular Goods; and

 (b) the Customer has met all other obligations due by the Customer to Exacon in respect of all contracts between Exacon and the Customer.
- Receipt by Exacon of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until then Exacon ownership or rights in respect of the Goods shall continue. 72

 It is further agreed that:
 (a) where practicable the Goods shall be kept separate and identifiable until Exacon shall have received payment and all other obligations of the Customer are met; and
 (b) until such time as ownership of the Goods shall pass from Exacon to the Customer Exacon may give notice in writing to the Customer to return the Goods or any of them to Exacon. Upon such notice the rights of the Customer to obtain ownership or any other interest in the Goods shall cease; and
 (c) Exacon shall have the right of stopping the Goods in transit whether or not delivery has been made; and
 - (d) if the Customer fails to return the Goods to Exacon then Exacon or Exaconagent may enter upon and
 - if the Customer fails to return the Goods to Exacon then Exacon or Exacohagent may enter upon and into land and premises owned, occupied or used by the Customer, or any premises as the invitee of the Customer, where the Goods are situated and take possession of the Goods; and the Customer is only a bailee of the Goods and until such time as Exacon has received payment in full for the Goods then the Customer shall hold any proceeds from the sale or disposal of the Goods, up to and including the amount the Customer owes to Exacon for the Goods, on trust for Exacon; and the Customer shall not deal with the money of Exacon in any way which may be adverse to Exacon and

 (g) the Customer shall not charge the Goods in any way nor grant nor otherwise give any interest in the Goods while they remain the property of Exacon; and

 (h) Exacon can issue proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods may not have passed to the Customer; and

 (i) until such time that ownership in the Goods passes to the Customer, if the Goods are converted into other products, the parties agree that Exacon will be the owner of the end products.

Defects

Defects

The Customer shall inspect the Goods on delivery and shall within seven (7) days of delivery (time being of the essence) notify Exacon of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Customer shall afford Exacon an opportunity to inspect the Goods within a reasonable time following delivery if the Customer believes the Goods are defective in any way. If the Customer shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which Exacon has agreed in writing that the Customer is entitled to reject, Exacori liability is limited to either (at Exacor discretion) replacing the Goods or repairing the Goods except where the Customer has acquired Goods as a consumer within the meaning of the Trade Practices Act 1974 (CWIM) or the Fair Trading Acts of the relevant state or territories of Australia, and is therefore also entitled to, at the consumer's discretion either a refund of the purchase price of the Goods, or repair of the Goods, or replacement of the Goods.

- Returns
 Returns will only be accepted provided that:
 (a) the Customer has complied with the provisions of clause 8.1; and
 (b) Exacon has agreed in writing to accept the return of the Goods; and
 (c) the Goods are returned at the Customer's cost (a pick up fee may apply) within seven (7) days of the delivery date; and
- delivery date; and

 (d) Exacon will not be liable for Goods which have not been stored or used in a proper manner; and

 (e) the Goods are returned in the condition in which they were delivered and with all packaging material,

 brochures and instruction material in as new condition as is reasonably possible in the circumstances.

 Exacon may (in its discretion) accept the return of Goods for credit but this may incur a handling fee of

 fifteen percent (15.0%) of the value of the returned Goods plus any freight.

Warranty
For Goods not manufactured by Exacon, the warranty shall be the current warranty provided by the manufacturer of the Goods. Exacon shall not be bound by nor be responsible for any term, condition, representation or warranty other than that which is given by the manufacturer of the Goods.

Default & Consequences of Default

- Default & Consequences of Default Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and one half percent (2.5%) per calendar month and such interest shall compound monthly at such a rate after as well as before any judgment. If the Customer defaults in payment of any invoice when due, the Customer shall indemnify Exacon from and against all costs and disbursements incurred by Exacon in pursuing the debt including legal costs on a solicitor and own client basis and Exacon' collection agency costs. Without prejudice to any other remedies Exacon may have, if at any time the Customer is in breach of any obligation (including those relating to payment). Exacon may suspend or terminate the supply of Goods to the Customer and any of its other obligations under the terms and conditions. Exacon will not be liable to the Customer for any loss or damage the Customer suffers because Exacon has exercised its rights under this clause. under this clause.
- under this clause. If any account remains overdue after thirty (30) days then an amount of the greater of twenty dollars (\$20.00) or ten percent (10.00%) of the amount overdue (up to a maximum of two hundred dollars (\$200.00)) shall be levied for administration fees which sum shall become immediately due and payable.
- Without prejudice to Exacori other remedies at law Exacon shall be entitled to cancel all or any part of any order of the Customer which remains unfulfilled and all amounts owing to Exacon shall, whether or not due for payment, become immediately payable in the event that:
 - (a) any money payable to Exacon becomes overdue, or in Exacon opinion the Customer will be unable to

 - (a) any money payable to exacon becomes overdue, or in exacon opinion the Customer will be unable to
 meet its payments as they fall due; or
 (b) the Customer becomes insolvent, convenes a meeting with its creditors or proposes or enters into an
 arrangement with creditors, or makes an assignment for the benefit of its creditors; or
 (c) a receiver, manager, fluidator (provisional or otherwise) or similar person is appointed in respect of
 the Customer or any asset of the Customer.

- Security And Charge
 Despite anything to the contrary contained herein or any other rights which Exacon may have howsoever:

 (a) where the Customer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Customer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to Exacon or Exacon nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Customer and/or the Guarantor acknowledge and agree that Exacon (or Exacon nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be withdrawn once

Cancellation

 Exacon may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Customer. On giving such notice Exacon shall repay to the Customer any sums paid in respect of the Price. Exacon shall not be liable for any loss or damage whatever arising from such cancellation.

 In the event that the Customer cancels delivery of Goods the Customer shall be liable for any loss incurred by Exacon (including, but not limited to, any loss of profits) up to the time of cancellation.
